The Guild assumes that it is the responsibility of the artist to honestly follow these guidelines and assumes no liability for work that is submitted or displayed if these guidelines are not followed. The Guild reserves the right to disqualify a painting if there is reasonable doubt about copyright infringement or plagiarism.

- Work entered for a show must be the artist's original work in concept and execution.
- Work cannot be copied from copyrighted material or photographs belonging to another person or organization except with the copyright holder's explicit written permission.
- Work cannot be the reproduction of a painting done by another person even if the original artist is acknowledged on the painting.
- Work cannot be the reproduction of a historic painting.


City of Campbell Launches New Art Project

With the help of several members of the Campbell Artists' Guild, the City of Campbell and its Civic Improvement Commission has just launched its utility box beautification project, *Art Outside the Box*. You may have noticed the results of such projects throughout San Jose or Santa Cruz, and other nearby cities where artist have undertaken the beautification of utility boxes.

Art Outside the Box provides an opportunity for artists residing in Santa Clara County to paint one of up to ten utility boxes throughout Campbell. It would be such a source of pride for the Guild if one or more artists from within our organization were selected to participate. An Honorarium is offered and the amount depends on the box selected. Box prep and sealing will be provided by the city. If you think you might be interested, please see the City's website www.cityofcampbell.com for links to more information on eligibility, guidelines, box locations, photos, plus instructions on how to submit your application and conceptual drawing.

To participate, you must be a resident of Santa Clara County. Your application and concept must be received by 5:00 p.m. on April 3, 2015.

If painting a utility box is not your strong suit, you may still participate by becoming a patron or donor (no amount is too small), and you may do so on the web site or in person.

BUSINESS Meeting Minutes February 12

The meeting was called to order by President Barbara Weiss at 1:45 p.m. In attendance were: Vice President Marlene Bird, Treasurer Sharon La Bouff, Membership Chair Barb Overholt, and Secretary Mary Kahn.

Discussion and Docket Items

- Artist of the Year: Artist of the Year competition needs to be added to the calendar. A list needs to be published with the names of candidates who are competing for the Artist of the Year title, so that if they choose, they may submit an entry for the March meeting which will enhance their eligibility to win the Artist of the Year competition in April. Also, the Artist of the Year competition will be part of the Guild's anniversary celebration in April.
- Artist of the Month: March will be the last competition for the 2014 fiscal year, and April will be the beginning of the 2015 Artist of the Month competition. The month of May will be the starting point for the Blue Ribbon Gallery competition.
- Demonstrations: It was proposed that we explore the topic of plein air techniques for the month of June and secure Dick Zunkel as our guest demonstrator to share his insights, strategies and experience on this subject. This demonstration will prove to be a valuable resource and preparation for our proposed field trip in July when Guild members will be able to implement what we have learned through independent practice in the field.
- The 2015 Programs calendar is tentatively scheduled up to the month of December. As a potential guest demonstrator/speaker for the month of October, Vice President Marlene Bird has suggested that we invite artist and local

gallery owner Khosrow Azarpour. He could educate our members and guests on criteria needed to get one's art into galleries, and possible ways in which to market artwork for sale.

- Annual Art Show: Volunteers are needed for hospitality and other duties associated with the annual art show which is held at Triton Museum's Rose Shenson Gallery.
- February General meeting: As a way in which to clarify and familiarize Guild members with the job descriptions, duties, and time required to fulfill officer positions, President Barbara Weiss has requested that each officer give a brief two-minute description of their position. Members are reminded to bring photographs with good composition and interesting subject matter to the February meeting. It will be at this meeting that photos will be selected for completion at the April meeting.
- **Exhibits**: The Corinthian House exhibit is currently running from February 9 April 13, 2015. A reception is being planned for the month of March but no date has been set at this time. Participating artists are to pick up their art on April 13. The Exhibits section in the newsletter needs to convey the location and address information of each exhibit along with the opening and closing dates for each venue. This information needs to be documented on the Guild's calendar of events.
- City of Campbell Utility Box Project: Treasurer
 Sharon La Bouff reported that applications are currently being accepted by the City of Campbell for their Utility Box Painting Project.
