Now that our Annual Art Show is over, I want to discuss competition of the set discuss something that I've touched on in past newsletters. The quote above reminds me of how the lack of an artist's confidence affects their fulfillment as an artist particularly when making a decision to exhibit their art before the public or enter into an art competition. Unless your ego is "oversized," most of us feel that trepidation that our art is not any good, that we cannot paint and are fooling ourselves into thinking otherwise. The idea of placing our art alongside someone else's seems to be inviting fear of rejection and unworthiness. Our fears and insecurities come into play because art bares our soul. And it doesn't help the situation that we have just begun taking workshops, classes, or just started dreaming about creating art. At this stage in our lives, we are called Emerging Artists.

Emerging Artists have yet to create a body of work let alone one art piece and have not yet exhibited in a show. Judgment is scary. If we don't receive a ribbon, we consider our art (and ourselves) unworthy.

So how can we deal with this? Some will say it doesn't matter. That creating art is its own reward. I agree that the actual creation of art is the highest fulfillment we receive as artists. But from the time we were children, we have wanted approval, that we "count," what we do has value. What can our Guild do to encourage and help all these emerging artists in our group?

The Guild is creating a monthly exhibit opportunity: *The Emerging Artists Gallery*. All members who identify themselves as new to creating art may exhibit in this monthly gallery. No pressure is on this group, there's no competition so ribbons will not be awarded.

President's Message



The Emerging Artists Gallery supports those who are learning through online courses, workshops, classes or are self-taught through art how-to books. The Guild hopes that after a year of this activity, these artists will develop the confidence and desire to create art on their own and enter into the Guild's monthly competitions.

Emerging Artists are encouraged to participate in the 27th Annual Art Show where a portion of the gallery's wall will be designated in displaying their art to the public. No ribbons will be awarded; there's no competition.

I invite all emerging artists to attend the Guild's Saturday afternoon *Painting Share* via Zoom. We share our art in progress and provide help (when asked) and encouragement to all those in attendance. It's a fun and unpretentious group.

Just a reminder to all artists, emerging and otherwise, that ribbons and awards are just opinions of a limited number of viewers or jurors. Even instructors are limited by history and what was once called good art. If we never changed the technical, creative processes, and art rules we use, we would not have the variety of art we now have. Can you imagine if Impressionism never existed?

During our September Membership Meeting, we will be discussing upcoming programs and getting your feedback on some new projects for your artistic involvement. More information is in this newsletter.

What Are Artists Trading Cards (ATCs)?

Artists Trading Cards are original works of art created on 2.5" x 3.5" pieces of material the artist chooses (e.g., canvas, paper, board, ...) in any medium chosen. Please create no more than two (2) ATCs and bring them to the meeting. The ATCs will be put on display at the beginning of the meeting and then transferred to their own envelopes. Only those artists who created ATCs are eligible to exchange ATCs until there are none left to trade.

How to Participate

- Participation is not mandatory.
- Artists may use any medium to interpret the theme on any substrate.
- Art will not be judged but if it is entered into a monthly competition, will adhere to the rules.
- No ribbons or awards will be presented.
- No framing is necessary but your art must be dry to handle by the specified deadline.
- If creations are made using dry media or water media on paper, the art should be under a matt for protection and, if available, a plastic sleeve.
- Artwork is presented to membership three (3) months from the date announced.
- Artists will share their finished art to membership; how they approached the project, medium used, etc.
- The use of copyrighted photos from any source is prohibited.
- Art created in workshops or online courses is prohibited.

Congratulations to Diann Klink!


Diann's painting, *Manakel's Dragon*, was recently accepted into the *Pacific Artistry Showcase 2024 Online Juried Exhibition*!

Competitions Briefly Explained *Please read the Bylaws for complete information*

Artist of the Month (AOM)

New Active members must attend one meeting before being eligible to compete. During the calendar year, Active members must attend at least one of three consecutive meetings prior to a competition.

Blue Ribbon Gallery (BRG)

Active members who have won a blue ribbon in the AOM competition (January–December) and who have attended at least one of three consecutive meetings prior to this competition are eligible to compete in the BRG for the remainder of the year. Previously awarded art from any AOM competition is not permitted.

Artist of the Year (AOY)

The AOY is held at the January Membership Meeting. Active members who have won a blue ribbon in the BRG, must attend at least one of three consecutive meetings prior to this competition for eligibility to compete.

Blue Ribbon Gallery ribbon recipients may enter a new or a previously awarded piece of art for this competition. First, second and third place ribbons are awarded at the January Membership Meeting.
